MEMBERSHIP REQUIREMENTS FOR FQM

## 1. MEET THE ADMISSION STANDARDS:

- Be 18 years of age or older;
- For people coming from outside Canada, have a document attesting that you can legally work (e.g. work permit);
- Have completed secondary V and/or the equivalent.

## 2e BUILDING YOUR FILE:

Please note that PDFs of these documents are available at the following address http://www.fqm.qc.ca/procedure-dadhesion-0.

- The completed and signed Application Form (PDF)
- The final attestation, with details of the hours of training taken in the accredited school (the diploma is optional).

  Please note that when joining the FQM, the new member is solely responsible for providing the final attestation from the school where the training was completed;
- A photocopy of the last academic diploma or transcript (high school, college or university);
- A colour photo of approximately 4 cm X 5 cm (passport size recommended);
- The curriculum vitae;
- The completed and signed Statutory Declaration (PDF);
- A photocopy of your birth certificate, baptismal certificate or passport;
- For people from outside Canada, you must provide a document attesting that you are legally entitled to work (e.g. permanent resident card, work permit);
- Completed and signed Letter of Consent (not required -PDF)
- Pay the \$57.49 fee, including taxes, covering the opening of the file and the processing of your application, as well as the membership fee which varies according to the month of membership (see 2nd page). The total amount can be paid by cheque to the order of the FQM, debit card (on site) or Visa or Mastercard credit cards.
- The completed training quality questionnaire (PDF)

Once your file is complete, we will send you the Welcome Kit which contains your attestation and membership card, tip sheets, The Massager, professional insurance information and two receipt books. This kit will give you all the tools to start your professional practice and/or your job search.

Please note that you can make an appointment and come to the FQM office, your file will be processed in about 15 minutes. If not, you will have to wait for the regular mail delays.
